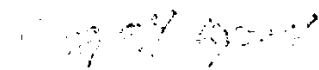

Subject: Comments regarding ISO/IEC JTC1/SC2 N2958
(1997-08-20) - Application number 202

We reviewed "DPRK Standard KPS 9566 - 97: Code of Korean Graphic Character Set for Information Interchange - Application number 202" and would like to make the following comments.

1. We are a little bit concerned about the fact that some syllables are included twice or three times. We would like to emphasize that this comment is based solely on the technical ground and therefore hope that DPRK also review this comment technically.

1.1 Multiple code positions for some syllables

- 1) Syllable **김** (GIM) appears in
 - row 17/column 14,
 - row 4/column 72, and
 - row 4/column 75
- 2) Syllable **일** (IL) appears in
 - row 43/column 46,
 - row 4/column 73, and
 - row 4/column 77
- 3) Syllable **성** (SEONG) appears in
 - row 26/column 34 and
 - row 4/column 74
- 4) Syllable **정** (JEONG) appears in
 - row 28/column 19 and
 - row 4/column 79

1.2 Possible Technical Problems

- 1) This multiplicity might cause a technical ambiguity.
- 2) For each of the four syllables, the first code position belongs to Korean syllables, whereas the other one or two code positions belong to "general graphic

characters". It seems somewhat confusing too.

3) Therefore, we suggest that DPRK and other experts review this situation and, if necessary, modify the proposal. We are willing to participate in such a review process.

1.3 Suggested Solutions

If it is concluded that the current situation needs be fixed, we can think of the following solutions.

1) Retain only one code position for each of the four syllables and leave the other code positions unused.

2) Assign only one code position for the three syllables, " 김일성 " (GIM IL SEONG), as a whole. In other words, one code position accommodates three syllables as one unit. The same applies to " 김정일 (GIM JEONG IL)".

2. 65 letters of Korean alphabet (Row 4/Columns 1-65)

1) These letters contain consonantal and vowel letters.

2) However, in ISO/IEC 10646-1, the block of Hangeul letters (code positions 1100-11FF) contains syllable-initial, syllable-peak, and syllable-final letters.

3) Considering that ISO/IEC 10646-1 is already an International Standard and will be widely used in the future, we suggest that DPRK review the possibility of including a set of syllable-initial, syllable-peak, and syllable-final letters instead of a set of consonantal and vowel letters.
