Old action items:

Jim: Part 2: Paragraph 12 should have (+, -, * or /) -> (+, -, * and /) - Done

Jim: Part 2: Page 8: Line 1: "are distinct types from float" -> "are distinct from the types float" - Done

Jim: Part 2: Page 32: The - sign seems to be in a different font and seems high. Try and make it look better. - Done

Jim: Part 2: Page 46: Change to split the table above into two 4 line chunks and use the individual rules per chunk. - Done

Jim: Part 2: Binding DFP applicable clauses in Annex F tighter to C11. Ex. Saying something like "An implementation that defines `__STDC_IEC_559_DFP__` shall conform to the specifications in clauses ... in this annex" - Done

Jim: Look into using the Wiki as a backup for the documents in Word format. - Most current version has been put up. Keep this item open.

All: Review Part 3. Comments via email. - Done

All: Let Jim know of any changes to part 2 as soon as possible. - Done

Jim: Part 2: Will go with `_Decimal32/64/128` ordering and Jim will follow up with Joseph to see if he agrees.

Jim: Part 2: Draft wording changes (based on Josephs email) regarding decimal vs generic radix 10 static rounding mode and we will review.

All: Part 2: A document will have to be delivered before the December meeting so please watch emails and respond quickly.

Jim: Part 1/2/3/4: Add a note regarding the a/b/c/... clause suffix meaning and reasoning for parts 2 on (since 1 is in ballot). Also check to see if this can be added in Part 1 as well.

Jim: Part 3: Try to use the math symbols for ceiling and floor instead of the words ceiling and floor.

Jim: Part 4: Look for opportunities for shortening function lists by removing suffixes.

Jim: Part 4: Send a note to the IEEE-754 group to get review of the draft from them.

Jim: Part 4: Remove the bold N in 5.3 function lists.

Jim: Part 4: Add in issue: We don't require conformance to part 3, and don't say `_FloatNx` (for example) must follow Part 3 so the functions are defined but are not the same as intended if an implementation has `_FloatNx` types but not Part 3 based.

Jim: Part 4: Pi functions: Drop the second "half-revolutions"

Jim: Part 4: `atan2pi`: Flag the description wording as an issue.

Jim: Part 4: `atan2pi`: Add in `atan2pi` has a domain error for both arguments being zero.

Jim: Part 4: `log21p`: Add in issue: It could be read as `log 21 p` instead of `log2 1p`.

Jim: Part 4: `rsqrt`: Need to add a domain error.

Jim: Part 4: `compoundn`: Add an issue: Why is it not an long long int?

Part 1:

Sent off for ballot.

Final ballot stage.

If approved, it will be an official published ISO technical specification.

Ian: Can be considered for C14 (next C standard revision).

Can only change very minor editorial things (ex. bullet point style).

Document is in SCC (Canada) already, but not necessarily up for ballot yet.

Part 2:

In WG14 review period. A step before the PDS ballot (the first ballot).

A draft was sent to Joseph Myers (very productive reviewer) and has commented on it. Jim has replied on the WG14 reflector.

Arguing for ordering of symbols related to decimal. Ex. `_Decimal64/32/128` is our current order and he wants `_Decimal32/64/128`.

Mike: 32 is not used and don't know any reason to use it. Use `128/64/32` instead.

Rajan: Parallels `double/float/long double`, or use small to large to allow adding new ones on later.

Mike: Any ordering is better than unordered.

AI Will go with `_Decimal32/64/128` ordering and Jim will follow up with Joseph to see if he agrees.

Constant rounding mode table: Asking for a similar table for decimal, new clarifications

Rajan: FLT_RADIX 10: Need to make sure we agree on making it clear which one takes precedence or make it implementation defined.

Ex. Can be last one wins or it can be biased towards the respective type. i.e. If both present, DEC -> Decimal if present, non-DEC does standard if present

Jim: An implementation may want to keep them separate even if the radix is 10. For implementation reasons they may make them the same.

Marius: For implementation I would think making them the same would be worse.

Jim: If standard control affects decimal types they would want the opposite to be true too. Decimal control affects standard types.

AI Jim to draft changes regarding the discussion above and we will review.

AI A document will have to be delivered before the December meeting so please watch emails and respond quickly.

Part 3:

Fred: Order of functions based by subclause number in C11 and subgroups are alphabetical. If we add new functions that will change subclause numbers.

Jim: We add letters to subclauses to avoid changing the numbers for later subclauses. Ex. 6.7.1.2#11 we add in 6.7.1.2#11a.

Mike: We could add a note describing why we are adding the a/b/c numbering.

AI Jim to add the note for parts 2 on (since 1 is in ballot). Also check to see if this can be added in Part 1 as well.

Fred: Why doesn't part 3 have the IEC_60559_TYPES with _EXT?

Jim: Part 1 shows the required things based on Annex F. The WANT macro is just an addition of identifiers for an extension. The programmer asks for these explicitly. The implementation must support these.

The goal is to have a WG14 review after the Spring 2014 meeting.

Mike: It is good to have Part 2 well underway before working on Part 3.

Jim: Part 2 should be available for ISO ballot next month.

Jim: One of the most complicated parts due to the type system changes and changes to part 1 and 2.

Mike: Some guidance on where to focus the review would be helpful.

Fred: ceil and ceiling issue: In C99 they use the mathematical symbol (L, backwards L etc.) vs the words.

AI Jim to try to use the math symbols for ceiling and floor instead of the words ceiling and floor.

Wording issue on page 20: Jim has talked to the C11 editor and is still looking into it.

Part 4:

Mike: Long lists of functions can cause oversights and missed functions. Perhaps group them using root names instead of listing them all.

Jim: Following part 2 and part 3, so this change would affect those as well.

AI Jim to look for opportunities for shortening function lists by removing suffixes.

Jim: This part was more straightforward as it was basically just adding functions so less interactions with other parts.

Will need help getting the special cases stated correctly.

AI Jim to send a note to the 754 group to get review from them.

Overview:

Is duplicating the intro section in all parts good?

No sentiment to remove it.

AI Remove the bold N in 5.3 function lists.

Rajan: *AI* Issue: We don't require conformance to part 3, and don't say `_FloatNx` (for example) must follow Part 3 so the functions are defined but are not the same as intended if an implementation has `_FloatNx` types but not Part 3 based.

Pi functions:

Fred: pg 5 ln 17: NaN is not in the interval but it shouldn't be a domain error.

Jim: Took it from text for `acos` directly from the C11 standard.

Fred: Not sure what the half-revolutions means. First and second instance.

Jim: Took it from the description of the trig functions.

David: The second one is redundant.

AI Jim to drop the second "half-revolutions"

`atan2pi`:

Fred: Can't figure out what the functions do from the description.

Jim: Using the 754 descriptions.

David: Can say it is y/x divided by Pi in the right hand plane mathematically.

Jim: Can refer to the mathematical `arctan` function.

Jim: There is no corresponding statement for that for `atan2`.

AI Jim to flag the description wording as an issue.

Fred: C11 says a domain error can occur if both arguments are zero.

AI Jim to add in `atan2pi` has a domain error for both arguments being zero.

`exp2m1`:

Fred: `exp2m1` (a large negative number) is not a range error.

Jim: Same as above. The words are from the C11 function.

`log21p`:

Jim: 754 has `log2p1`. We already have `log1p` with the same description.

AI Issue here since it could be read as `log 21 p` instead of `log2 1p`.

rsqrt:

AI Need to add a domain error.

compoundn:

Fred: Why are we using long int?

Jim: This was from the earlier discussion we had.

Ian: More instructions are needed for PPC hence long int is more efficient.

AI Jim to mark this as an issue as to why is it not an long long int.
