2. Change History

2.1 September, 1995

Changes to the schedule were made reflecting the new DIS policy in JTC1 and the anticipated need for a second (final) CD. We also decided to take two meetings to resolve CD and Final CD ballot comments, rather than only one. The DIS balloting schedule was reduced from 6 to 4 months. This schedule was approved at the 1995 SC22 Plenary meeting in Annapolis, MD.
